

Friend and Fellow American,

I am writing because I am very concerned about the current health care reform being discussed by our President and Congress. Perhaps you've heard the reports on the news. Maybe you've overheard friends or co-workers discussing it.

While the terms of the debate may be confusing, one thing I can say is this: almost everyone who reads the bill is getting worried about it. A growing majority of Americans (54%) now think that doing nothing is better than doing what's being proposed. The trend is speeding in this direction, as more people educate themselves.

I'm writing because I care about my children, about you and about our country. I just wanted to pass along some information that I think you might find helpful. There's information about the bill, links so you can read it yourself, if you want to. There are changes we can make to our health system, which I think would make it better. Unfortunately, the changes being suggested will only make it far worse, and bring America to a place where freedoms are limited by a government which in recent years has seemed to do far more wrong than right.

This current bill contains alarming measures. The government will define what services insurance companies must cover, including controversial measures like abortion. The government will also prohibit insurance companies from writing new policies. End of life issues will be handled under the supervision of a government agency. Companies and citizens will be taxed for choosing to keep their own policies. The government will mandate doctors' salaries. I have attached some documents that locate these provisions in the current bill. *And I am only scratching the surface.*

Perhaps this is your introduction into the debate. Maybe you've never cared anything about politics before. May I suggest that this isn't about politics? This is about our freedom and way of life. I would encourage you to read the attached documents and make a decision for yourself. If you are alarmed as so many people are, consider doing a couple of things:

1. Write a letter or call your senator and congressional representative, telling him to vote no. If you don't know how to do this, join <http://www.thepeopledecide.us> and you can find information regarding who your representatives are and how to contact them.

## How will the Health Care Bill Affect You if it is Passed?

These are a few highlights from a thorough summary presented by the Liberty Counsel. Please download the entire bill at the following address and see for yourself: <http://tinyurl.com/hr3200bill>

(Page 16: Eliminates the choice to purchase or keep private health insurance. This would happen gradually.)

Sec. 122, Pg. 29, Lines 4-16: YOUR HEALTH CARE WILL BE RATIONED! *(This means that you will have to wait to see a doctor as they do in Canada, and you may be told you can't get the treatment you need.)*

Sec. 123, pg 30: A GOVERNMENT COMMITTEE will decide what treatments and benefits you get.

Sec. 163, Pg 58-59: A National ID Health Care card will be issued. Government will have access to your finances. This includes access to your bank accounts for electronic funds transfer.

Sec.201, Pg. 72, Lines 8-14: Government is creating a Health Care Exchange to bring private plans under government control.

Sect. 312, Pg 145, Line 15-17 of HC Bill—An Employer MUST auto-enroll employees into public option plan, NO CHOICE.

Sec. 401.59B, Pg 167, Lines 18-23: ANY individual who does not have acceptable health care, according to Government, will be taxed 2.5% of income.

Sect. 1121, Pg 239, Line 14-24 of HC Bill—Government will limit and reduce physician services for Medicaid. Seniors, low income and poor are the ones affected.

Sect. 1177, Pg 354—Government will RESTRICT enrollment of Special needs people!

Sect. 1233, Pg 427, Lines 15-24—Government mandates program for orders for life-sustaining treatment (i.e. end of life). The Government has a say in how your life ends.

Sect. 1233, Pg 429, Lines 10-12 “Advanced Care Consultation” may include an ORDER for end of life plans. AN ORDER from GOVERNMENT!

Sect. 1308, Pg. 489 – the government will cover Marriage and Family therapy. This will involve government control of your marriage.

Sect. 1714, Pg. 769 – Federal government mandates eligibility for State Family Planning Services. Abortion and government control intertwined.

Sect. 1904, Pg. 843 – 844 A Home Visitation Program that includes the government coming into your house and teaching/telling you how to parent.
